The antecedent of a pronoun is the word to which the pronoun refers. The pronoun and its antecedent agree in gender and number. Jane called her friend. Jane and her are both singular and feminine. John called his friend. John and his are both singular and masculine. The girls finished their job. The plural pronoun agrees with the plural antecedent.

A pronoun agrees with its antecedent in number, gender, and person. If the antecedent is singular, If the antecedent is singular, a singular pronoun is required. The plural antecedent requires a plural pronoun.

Whether singular or plural, it is important for a pronoun and its antecedent to agree. An antecedent is the noun to which a pronoun refers. If you remember that a pronoun must make reference to a noun and that the noun should be close to the pronoun, you will find it easier to make pronouns agree with their antecedents.

Whenever you use a personal pronoun like she, it, or they, you first have to have an antecedent, the word that the pronoun is replacing. Read this sentence: Gustavo slowed to the speed limit when he saw the police cruiser in the rearview mirror. The pronoun he replaces Gustavo.
